Qualifications

For International Students

Foreign nationals who fall under any of the following three conditions;

1. Those who have completed, or are expected to complete, a 12-year curriculum by March 31, 2021, in an education system outside Japan and are qualified to enter universities in that country, or equivalent.

If any of the following i) to vi) is met, we consider Qualification 1 is satisfied.

- i) Those who completed a regular 12-year school curriculum in less than 12 years by the academic acceleration systems such as “skipping grades”.
 - ii) Those who have graduated from a foreign school with a regular education course of less than 12 years before entering university, and completed a preparatory education course at an educational facility designated by the Minister of Education, Culture, Sports, Science and Technology (MEXT).
 - iii) Those who have graduated from a foreign school with a regular education course of less than 12 years before entering university, and are recognized by the official certification of the country as having completed the education equivalent to 12 years of education in Japan.
 - iv) Those who satisfy the requirements such as being deemed to have completed a designated course of not less than 11 years and have completed a course of a school in a foreign country with the educational curriculum approved by the MEXT as corresponding to the upper secondary school in Japan.
 - v) If those whose 12-year educational history includes the period of enrollment in Japan, the total enrollment period throughout the secondary education is less than 3 years, and have graduated from an upper secondary school in a foreign country, he/she can apply for the entrance examination. In this case, the primary education period does not count.
 - vi) Those who have successfully passed an academic qualification examination in a foreign country that is equivalent to the completion of 12 years of schooling in Japan.
2. Those who are approved by Tokyo University of Agriculture that he/she has an equivalent ability to have completed 12 years of the regular school curriculum.
 3. Those who have acquired a qualification entering universities in a foreign country, the International Baccalaureate, the Abitur, the Baccalauréat, or the General Certificate of Education (GCE) Advanced Level (A Level).

For Returnees

Those who have Japanese nationality, and have been enrolled overseas for 2 years or more in an upper secondary school based on an educational curriculum outside of Japan including the final grade, and completed the regular 12-year school education in the last 2 years, or are expected to complete the regular 12-year school education by March 31, 2021.
